#### COOLING-OFF PERIOD

#### INVESTMENT OBJECTIVE AND STRATEGY

The Investor Fund is a USD-denominated equity Unit Investment Trust Fund structured as a feeder fund and aims to provide market returns from a representative portfolio of stocks that comprise the European Equity Market by investing at least 90% of its assets in the iSHARES MSCI EUROZONE ETF. The Fund's benchmark is the MSCI Daily TR Net EMU (NDDUEMU Index).

#### CLIENT SUITABILITY

A client profiling process is performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are encouraged to update the resulting profile every three (3) years or if there's any change in his/her personal/financial circumstances. Before deciding to invest, clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, or seek an independent/professional opinion when necessary.

#### The METRO\$ EUROZONE EQUITY FEEDER FUND

(formerly Metro\$ MSCI Eurozone Feeder Fund) is suitable only for investors who:

- Have an Aggressive profile.
- Want capital appreciation over the long-term by primarily investing in iSHARES MSCI EUROZONE ETF
- Recommended investment horizon is at least five (5) years
- Participation in the Fund shall be open to Filipino individuals, resident and non-resident aliens and corporate accounts.

#### KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

<b>Market/Price Risk:</b>	The possibility for an investor to experience losses due to changes in the market prices of stocks/equities. It refers to the portfolio's exposure to marked-to-market valuation due to market price fluctuations of the stocks/equities.
<b>Liquidity Risk:</b>	The possibility for an investor to experience losses due to the inability to sell or convert assets into cash immediately or in instances where conversion to cash is possible but at a price that could result in a loss. 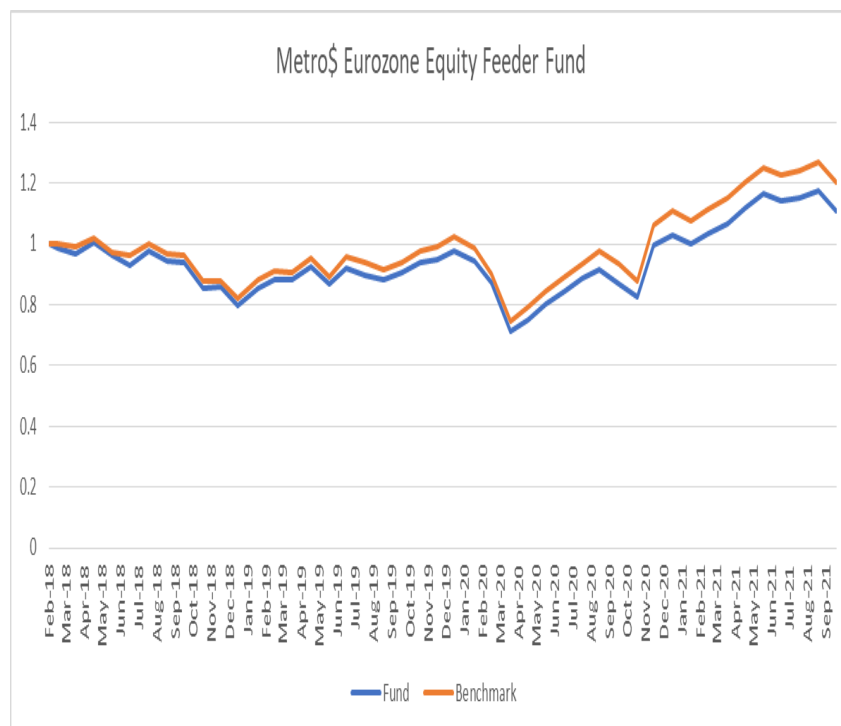

<sup>4</sup> Information Ratio measures reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk.

<sup>5</sup> Tracking Error measures the deviation between the Fund's return and benchmark return since the Fund's inception. The lower the number, the more aligned the Fund's return is with the benchmark. (Starting September 2021 report the basis for the Tracking Error computation is since the Fund's inception.)

## INVESTMENT POLICY

A. The Fund may be invested and reinvested in the following instruments:

- USD-denominated units/shares in collective investment schemes subject to the conditions under BSP Circular 767
- USD-denominated deposits
- Other traded money market instruments
- Other USD-denominated Investments allowed under BSP regulations

B. The Investor Fund may invest a minimum of 90% of its fund in the Target Fund and a maximum of 10% in cash, deposits and other money market instruments. The investment of the Investor Fund in any one Target Fund shall not exceed 10% of the Total Net Asset Value of the Target Fund.

## OUTLOOK AND STRATEGY

Global equity markets fell for the month amid slower pace of post-quarantine/lockdown economic recovery. Covid-19 infection rate seemed to have peaked particularly in developed economies while emerging countries show improving vaccination rates which could further support economic activity and growth. Emerging markets shares underperformed relative to developed market shares dragged by the sell-off in Chinese equities over contagion fears in relation to property giant Evergrande debt crisis. Sharp rise in interest rates weigh down the equity markets with value stocks outperforming growth stocks; giant technology companies took the hardest hit as investors shift growth outlook and sentiment towards cyclical companies. Commodity price increases during the month was amplified by energy prices climbing abruptly mainly due to demand and supply imbalance as consumers return to pre-pandemic consumption patterns.

Eurozone equity share prices fell despite starting the month strong as concerns over supply chain disruption together with spike in energy prices dampen growth prospects. Furthermore, softer growth in the service and manufacturing sector reduced positive investor sentiment with service purchasing manager's index (PMI) falling to 56.3 from 59 a month ago and manufacturing PMI slid to 58.7 from 61.4. European Central Bank announced that it will conduct its asset purchases under the Pandemic Emergency Purchase Program (PEPP) at a moderately slower pace with market estimating bond purchases to be reduced from EUR 80 billion to EUR 70 billion; but unlikely to increase policy rate soon despite latest inflation for Euro area show rising prices at 3.4% YoY from 3% YoY a month ago stating it can tolerate moderate and transitory overshoot of its inflation target.

The target fund declined by 5.05% month-on-month with the energy sector recording the most gains as oil and energy prices rose during the month. TotalEnergies SE produces and supplies oil and natural gas posted the largest gain for the fund at 0.19% benefitting from rising oil prices; it also caught investor's interest as a significant portion of its capital expenditure was allocated for the development of renewable energy which pushed its share price higher by 11% MoM. However, utility sector printed the most losses unable to capitalize in energy price gains as price caps were implemented by some Eurozone countries. Information technology shares sell-off as preference for growth stocks decline amid rising yields made the sector the main drag for the fund.
