INVESTMENT OBJECTIVE AND STRATEGY

The Investor Fund intends to achieve for its participants long-term capital growth by investing in a diversified portfolio of US Dollardenominated collective investment schemes. The Investor Fund will have more than one (1) Target Funds at any given time. The Target Funds may be changed from time-to-time subject to regulations and the stipulations contained in the Declaration of Trust. The Fund's benchmark is the MSCI ACWI Net Total Return USD Index.

CLIENT SUITABILITY

A client profiling process is performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are encouraged to update the resulting profile every three (3) years or if there's any change in his/her personal/financial circumstances. Before deciding to invest, clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, or seek an independent/professional opinion when necessary.

• Have an Aggressive profile.

• Want capital appreciation over the long-term by investing in more than one Target Funds at any given time.

• Recommended investment horizon is at least five (5) years



- Global-denominated deposits with local banks/foreign banks

• Financial derivative instruments for hedging purposes and efficient portfolio management.

C. The Investor Fund may invest a minimum of 90% of its net asset value in more than one (1) Target Fund and a maximum of 10% in cash, deposits and other money market instruments

OUTLOOK AND STRATEGY

Risk-off tone seen in the global equities market faced with volatility and numerous headwinds as it closed the month in the red. One of the main culprits is the uncertainty surrounding the US Federal Reserve's timing on tapering of its bond purchases and eventual lifting of its benchmark rates. Persistent inflation pressures over supply disruptions have pushed some central banks to express a more hawkish forward guidance and monetary policies leading to rising yield expectations thus making equity valuations more vulnerable. Increasing concerns towards the more contagious Delta COVID-19 variant has challenged investor's optimism on global economies' reopening and recovery. Additionally, continued regulatory crackdown in China and potential default of heavily indebted Chinese property developer has also further dampened sentiments across markets.

USDPHP closed at a fresh YTD high of 51.00 (+1.24 MoM) following hawkish remarks from the Federal Reserve hinting to hike benchmark rates early 2022 and preparing to initiate tapering of its asset purchases. With the nation being a net importer of goods, soaring global commodity prices, like oil, along with quarterly funding requirements puts upward pressure to the pair.

While the economy remains fragile during the pandemic, long-term structural drivers of the underlying themes in the fund remain intact. Short-term pullbacks present investment opportunities to take advantage in capturing long-term growth trends as businesses operate and consumers embrace the new normal and welcome fresh dynamics brought by the lessons learned in the past two years.
