### COOLING-OFF PERIOD

### INVESTMENT OBJECTIVE AND STRATEGY

The Investor Fund is a USD-denominated equity Unit Investment Trust Fund structured as a feeder fund and aims to provide market returns from a representative portfolio of stocks that comprise the European Equity Market by investing at least 90% of its assets in the iSHARES MSCI EUROZONE ETF. The Fund's benchmark is the MSCI Daily TR Net EMU (NDDUEMU Index).

### CLIENT SUITABILITY

A client profiling process is performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are encouraged to update the resulting profile every three (3) years or if there's any change in his/her personal/financial circumstances. Before deciding to invest, clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, or seek an independent/professional opinion when necessary.

### The METRO\$ EUROZONE EQUITY FEEDER FUND is suitable only for investors who:

- Have an Aggressive profile.
- Want capital appreciation over the long-term by primarily investing in iSHARES MSCI EUROZONE ETF
- Recommended investment horizon is at least five (5) years
- Participation in the Fund shall be open to Filipino individuals, resident and non-resident aliens and corporate accounts.

### KEY RISKS AND RISK MANAGEMENT

<b>Market/Price Risk:</b>	The possibility for an investor to experience losses due to changes in the market prices of stocks/equities. It refers to the portfolio's exposure to marked-to-market valuation due to market price fluctuations of the stocks/equities.
<b>Liquidity Risk:</b>	The possibility for an investor to experience losses due to the inability to sell or convert assets into cash immediately or in instances where conversion to cash is possible but at a price that could result in a loss. 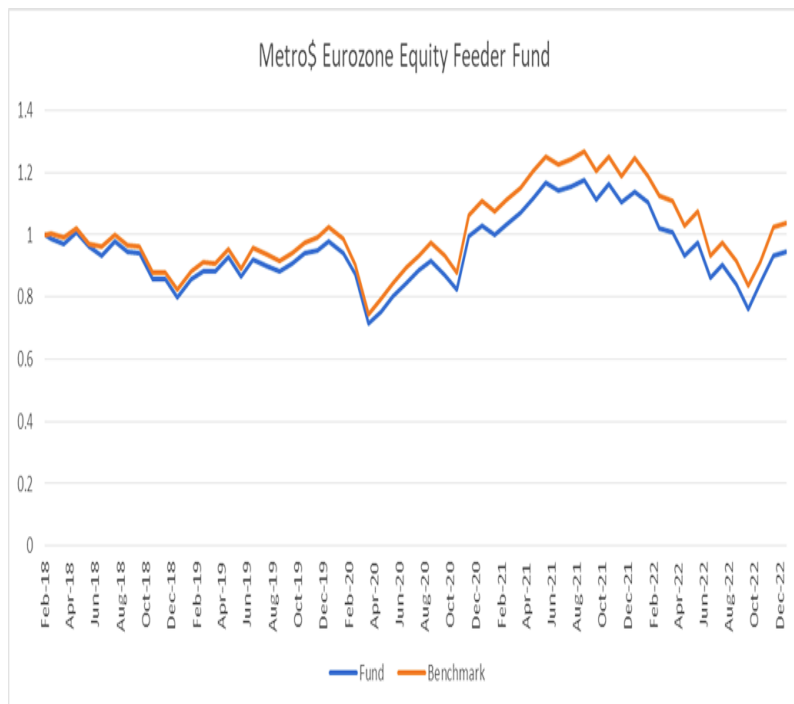

<sup>4</sup> Information Ratio measures reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk.

<sup>5</sup> Tracking Error measures the deviation between the Fund's return and benchmark return since the Fund's inception. The lower the number, the more aligned the Fund's return is with the benchmark. (Starting September 2021 report the basis for the Tracking Error computation is since the Fund's inception.)

## INVESTMENT POLICY

A. The Fund may be invested and reinvested in the following instruments:

- USD-denominated units/shares in collective investment schemes subject to the conditions under BSP Circular 767
- USD-denominated deposits
- Other traded money market instruments
- Other USD-denominated Investments allowed under BSP regulations

B. The Investor Fund may invest a minimum of 90% of its fund in the Target Fund and a maximum of 10% in cash, deposits and other money market instruments. The investment of the Investor Fund in any one Target Fund shall not exceed 10% of the Total Net Asset Value of the Target Fund.

## OUTLOOK AND STRATEGY

The fund grew 1.11% mirroring the target fund's return of 0.73% in December. Shares in Europe fell sharply in December on renewed concerns about a looming economic slowdown and rising interest rates. In local currency terms, the pan-European STOXX Europe 600 Index ended more than 3% lower. Major indexes in France, Italy and Germany fell by a similar amount. The UK's FTSE 100 Index also pulled back but lost less ground. The European Central Bank (ECB) raised its key interest rate by 50bps to 200bps. Although the increase marked a slowdown from the two previous rate hikes, ECB President Christine Lagarde said rates "will still have to rise significantly at a steady pace to reach levels that are sufficiently restrictive" to bring inflation back down to the 2% target. The ECB also said that starting March 2023, they will begin to shrink the portfolio accumulated as part of its Asset Purchase Programme. However, despite the drop in European stocks and hawkish statements from the ECB, the fund still managed to close the month on a positive note MoM due to the individual stock holdings of the target fund. 8 out of the top 10 holdings of EZU Fund had positive MoM returns for December led by ASML Holding N.V. (+8.36%) and SAP GY Equity (+5.63%). ASML Holding N.V. is the fund's top holdings which accounts for more than 5% of the total fund. ASML is a company based in Netherlands which develops, produces and markets semiconductor manufacturing equipment.

YTD, the fund fell -17.23% while the target fund posted a deeper loss of -18.45% in 2022.
