### COOLING-OFF PERIOD

Further, the net amount of payment or delivery due the TRUSTOR shall be based on the transaction day's NAVPU when notice of redemption, termination or cancellation was received.

### INVESTMENT OBJECTIVE AND STRATEGY

The Investor Fund is a USD-denominated equity Unit Investment Trust Fund structured as a feeder fund and aims to provide market returns from a representative portfolio of stocks that comprise the Japan Equity Market by investing at least 90% of its assets in the iSHARES MSCI JAPAN ETF. The Fund's benchmark is the MSCI Daily TR Net Japan (NDDUJN Index).

### CLIENT SUITABILITY

A client profiling process is performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are encouraged to update the resulting profile every three (3) years or if there's any change in his/her personal/financial circumstances. Before deciding to invest, clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, or seek an independent/professional opinion when necessary.

### The METRO\$ JAPAN EQUITY FEEDER FUND is suitable only for investors who:

- Have an Aggressive profile.
- Want capital appreciation over the long-term by primarily investing in iSHARES MSCI JAPAN ETF
- Recommended investment horizon is at least five (5) years
- Participation in the Fund shall be open to Filipino individuals, resident and non-resident aliens and corporate accounts.

### KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

<b>Market/Price Risk:</b>	The possibility for an investor to experience losses due to changes in the market prices of stocks/equities. It refers to the portfolio's exposure to marked-to-market valuation due to market price fluctuations of the stocks/equities.
<b>Liquidity Risk:</b>	The possibility for an investor to experience losses due to the inability to sell or convert assets into cash immediately or in instances where conversion to cash is possible but at a price that could result in a loss. 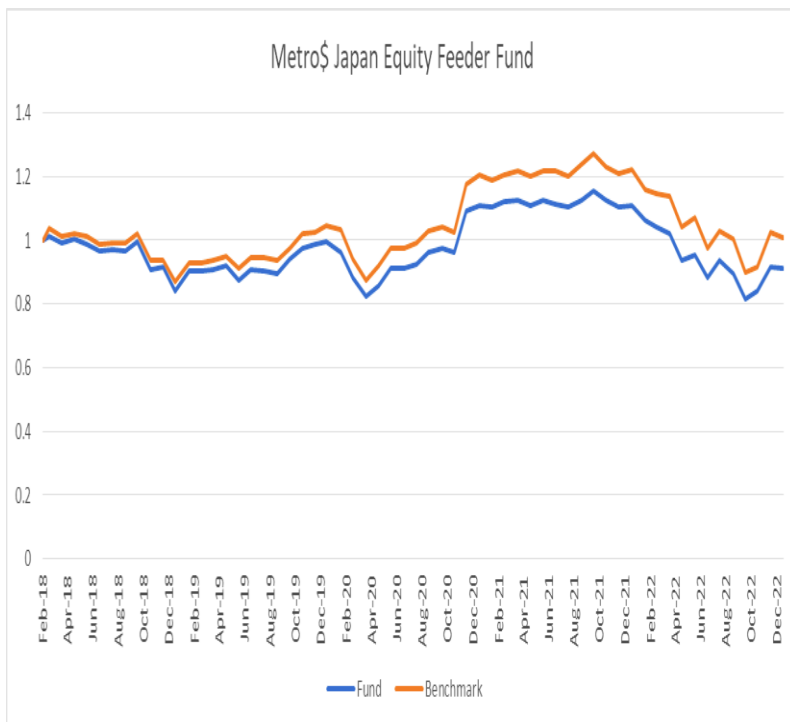

<sup>3</sup> Sharpe Ratio is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better.

<sup>4</sup> Information Ratio measures reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk.

<sup>5</sup> Tracking Error measures the deviation between the Fund's return and benchmark return since the Fund's inception. The lower the number, the more aligned the Fund's return is with the benchmark. (Starting September 2021 report the basis for the Tracking Error computation is since the Fund's inception.)

## INVESTMENT POLICY

A. The Fund may be invested and reinvested in the following instruments:

- USD-denominated units/shares in collective investment schemes subject to the conditions under BSP Circular 767
- USD-denominated deposits
- Other traded money market instruments
- Other USD-denominated Investments allowed under BSP regulations

B. The Investor Fund may invest a minimum of 90% of its fund in the Target Fund and a maximum of 10% in cash, deposits and other money market instruments. The investment of the Investor Fund in any Target Fund shall not exceed 10% of the Total Net Asset Value of the Target Fund.

## OUTLOOK AND STRATEGY

The fund slipped -0.22% while the target fund posted a wider loss of -0.58% in December. Japanese equities had a weak December, with the MSCI Japan Index falling 5.2% in local currency terms. Risk appetite suffered due to the Fed's continued hawkish stance even as inflation showed signs of tapering off. The Bank of Japan (BoJ) surprised markets in the latter half of the month by announcing that it would modify its policy of yield curve control, allowing 10-year government bond yields to rise as high as 50bps, doubling its prior implicit cap of 25bps. Most market participants had not expected a shift in the BoJ's yield curve control until 2023. As a result, the government bond yields finished December at around the 0.42% level, up sharply from 25bps at the end of the prior month.

YTD, the fund fell -17.74% while the target fund posted a deeper loss of -18.06% in 2022.
