INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve for its participants maximum growth from a portfolio of diversified equities listed at the Philippine Stock Exchange (PSE) which the Fund are tax-exempt in accordance with the PERA Law. The Fund's composite benchmark is composed of Philippine Stock Exchange Index.

CLIENT SUITABILITY

A client profiling process is performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are encouraged to update the resulting profile every three (3) years or if there's any change in his/her personal/financial circumstances. Before deciding to invest, clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, or seek an independent/professional opinion when necessary.

The METROBANK PERA EQUITY FUND is suitable only for investors who:

- Have an Aggressive profile.
- Want capital growth over the long-term and are willing to be exposed to a higher level of risk that may involve possible loss of principal in the short-term in exchange for higher long-term gains.
- Recommended investment horizon is at least five (5) years
- Filipino individuals with legal capacity to contract and possesses a Tax Identification Number (TIN)

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk:	The possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.
Market/Price Risk:	The possibility for an investor to experience losses due to changes in the market prices of bonds. It refers to the portfolio's exposure to marked-to-market valuation due to market price fluctuations of the bonds.

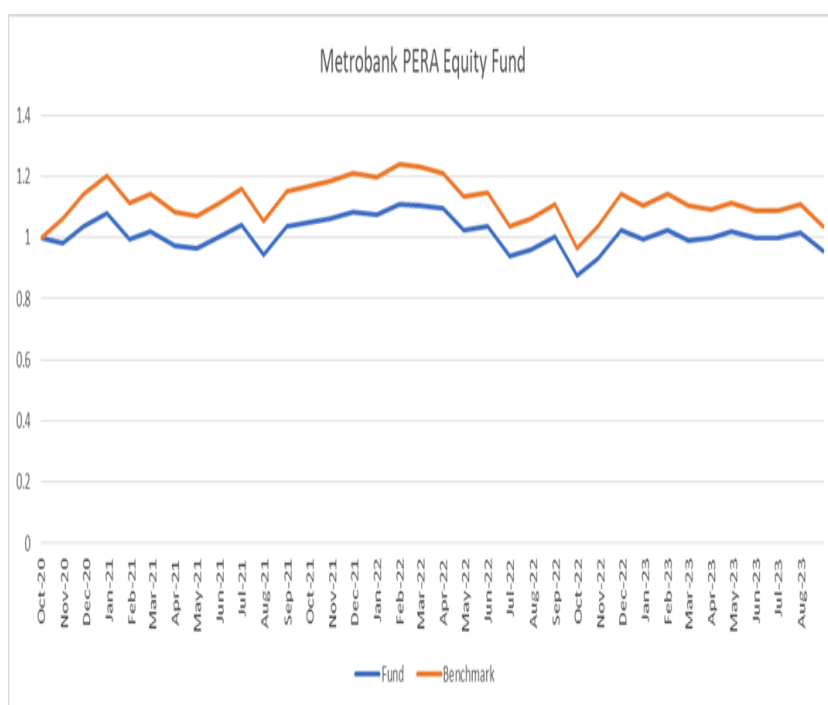

OUTLOOK AND STRATEGY

August, traditionally known as the "ghost month," had a lot in store for the PSEI which faced a significant downturn alongside all of its sectoral indices, declining by -6.3% compared to the previous month, settling at 6,175. Several key factors contributed to this market decline. Notably, the second-quarter GDP growth for 2023 disappointed, registering only 4.3% year-on-year, well below market expectations of 6.0%. This was primarily due to a 7.1% year-on-year contraction in government spending, which offset gains in consumer spending, agriculture, industry, and services.

Furthermore, July's headline inflation slowed to 4.7%, surpassing the street consensus of 5%. This deceleration was driven by base effects resulting from lower energy prices. Despite this economic landscape, the BSP decided to maintain its policy rates at 6.25% during its meeting. Interestingly, BSP Governor Remolona hinted at a cautiously hawkish stance, suggesting that rates could remain elevated if inflation trends upward, aligning with the direction of the Federal Reserve.

The month featured important market flows, including the PSEI rebalancing at the beginning of the month, which led to increased weights for ACEN, BPI, and UBP without any additions or deletions. However, at month-end, MSCI rebalancing-related flows exerted downward pressure on the index, resulting in net foreign selling of USD 131 million. Both rebalancing activities boosted market liquidity, with daily turnover averaging about Php5.5 billion. On Corporates, the talk of the town was the Sy-led property giant, SMPH (-12.6% MoM) which coincidentally is among the biggest drags for the month amid its ongoing reclamation project controversy wherein the DENR suspended all reclamation projects in Manila Bay, directly impacting SMPH's major projects in Pasay and Paranaque. These projects represent nearly 40% of its Net Asset Value (NAV), hence the weakness in price.

Given the prevailing uncertainties in the equities markets, a cautious approach is advised. The banking sector stands to benefit amid elevated interest rates, while the consumer sector may face increased volatility due to rising commodity prices. Surprisingly, the Property sector showed signs of positivity, particularly in the residential segment, alongside a robust mall segment. Overall, market sentiment remains subdued, with bonds offering more attractive returns.
