INVESTMENT OBJECTIVE AND STRATEGY

The Investor Fund is a USD-denominated equity Unit Investment Trust Fund structured as a feeder fund and aims to provide market returns from a representative portfolio of stocks that comprise the China Equity Market by investing at least 90% of its assets in the iShares MSCI China A UCITS ETF USD.

The Fund's benchmark is the MSCI China A Inclusion Net Return USD Index (M1CNA).

CLIENT SUITABILITY

A client profiling process is performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are encouraged to update the resulting profile every three (3) years or if there's any change in his/her personal/financial circumstances. Before deciding to invest, clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, or seek an independent/professional opinion when necessary.

The METRO\$ CHINA EQUITY FEEDER FUND is suitable only for investors who:

- Have an Aggressive profile.
- Want capital appreciation over the long-term by primarily investing in iShares MSCI China A UCITS ETF USD.
- Recommended investment horizon is at least five (5) years
- Participation in the Investor Fund shall be open to Filipino individuals, resident and non-resident aliens, and corporate accounts. However, persons from US, and Canada are not allowed to open an account.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Market/Price Risk:	The possibility for an investor to experience losses due to changes in the market prices of stocks/equities. It refers to the portfolio's exposure to marked-to-market valuation due to market price fluctuations of the stocks/equities.
Liquidity Risk:	The possibility for an investor to experience losses due to the inability to sell or convert assets into cash immediately or in instances where conversion to cash is possible but at a price that could result in a loss. 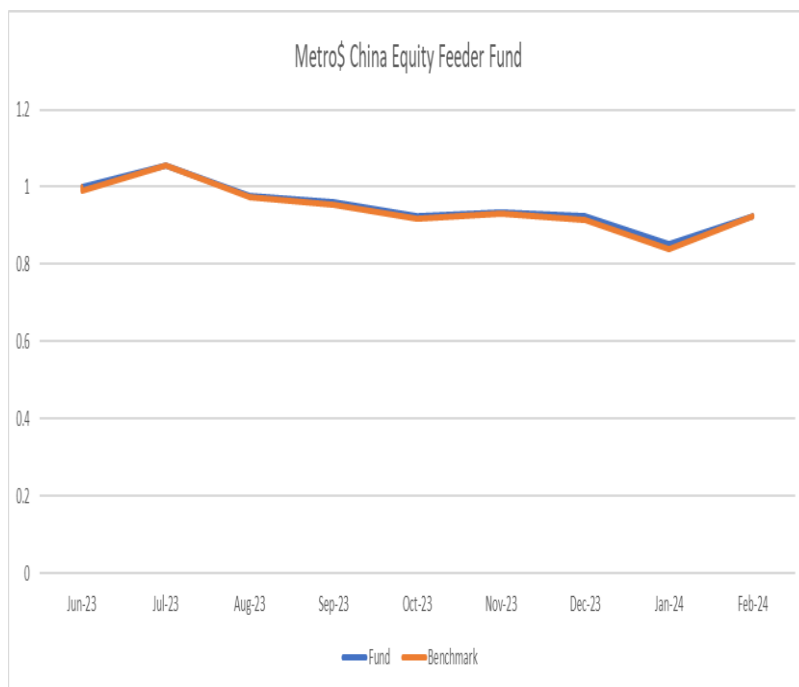

⁴ Information Ratio measures reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk.

⁵ Tracking Error measures the deviation between the Fund's return and benchmark return since the Fund's inception. The lower the number, the more aligned the Fund's return is with the benchmark. (Starting September 2021 report the basis for the Tracking Error computation is since the Fund's inception.)

INVESTMENT POLICY

A. The Investor Fund may be invested and reinvested in the following instruments:

- USD-denominated units/shares in more than one collective investment schemes subject to the conditions under BSP Circular 767
- USD-denominated money market instruments
- USD/PHP-denominated deposits
- Other USD-denominated Investments allowed under BSP regulations

B. The Target Fund may be invested and reinvested in the following instruments:

- Global-denominated Investments allowed under regulations issued by the Bangko Sentral Ng Pilipinas;
- Global-denominated Exchange-listed securities;
- Global-denominated deposits with local banks/foreign banks
- Financial derivative instruments for hedging purposes and efficient portfolio management.

C. The Investor Fund may invest a minimum of 90% of its net asset value in more than one (1) Target Fund and a maximum of 10% in cash, deposits and other money market instruments

OUTLOOK AND STRATEGY

The fund increased by 8.41% for the month of February. A sharp rally in the market as Chinese authorities aimed to halt the falling stock market with direct intervention.

The People's Bank of China (PBOC) cut the 5-year loan rate by 25 bps to 3.95%, the largest cut since it was introduced in 2019 to support demand in the ailing property sector. Chinese home prices contracted for the seventh consecutive month as construction delays have kept buyers cautious.

China's economy continued to deflate as CPI printed -0.8% YoY from -0.3%, producer prices declined 2.5% YoY. Both manufacturing and services PMI remained weak but showed improvement at 49.2 and 50.7, respectively.

China's equity market led global markets as Chinese authorities poured money into stocks to halt the foreign exodus. State backed institutions supported markets in a full-fledged monetary and fiscal effort to force markets to bottom-out. The support triggered a sharp price pivot in Chinese stocks, quickly pushing the market into an overbought state. More evidence would be required to confirm the bottoming of Chinese equities and its housing market.

In the short to medium term, the reflation risk has been an emerging concern, given fiscal spending ahead of the 2024 U.S. Presidential elections, improving PMI data, and equity markets hitting new all-time highs. Tensions in the Middle East have also driven WTI to increase by 3.17% for the month, bringing the YTD increase to 11%.

The fund is capitalizing on favorable dollar time deposit rates, offering a 60-day yield of 5.20%, for any excess liquidity.
