INVESTMENT OBJECTIVE AND STRATEGY

The Investor Fund is a USD-denominated equity Unit Investment Trust Fund structured as a feeder fund and aims to provide market returns from a representative portfolio of stocks that comprise the Japan Equity Market by investing at least 90% of its assets in the iSHARES MSCI JAPAN ETF. The Fund's benchmark is the MSCI Japan Net Total Return USD Index.

CLIENT SUITABILITY

A client profiling process is performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are encouraged to update the resulting profile every three (3) years or if there's any change in his/her personal/financial circumstances. Before deciding to invest, clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, or seek an independent/professional opinion when necessary.

The METRO\$ JAPAN EQUITY FEEDER FUND is suitable only for investors who:

- Have an Aggressive profile.
- Want capital appreciation over the long-term by primarily investing in iSHARES MSCI JAPAN ETF
- Recommended investment horizon is at least five (5) years
- Participation in the Fund shall be open to Filipino individuals, resident and non-resident aliens and corporate accounts.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Market/Price Risk:	The possibility for an investor to experience losses due to changes in the market prices of stocks/equities. It refers to the portfolio's exposure to marked-to-market valuation due to market price fluctuations of the stocks/equities.
Liquidity Risk:	The possibility for an investor to experience losses due to the inability to sell or convert assets into cash immediately or in instances where conversion to cash is possible but at a price that could result in a loss. 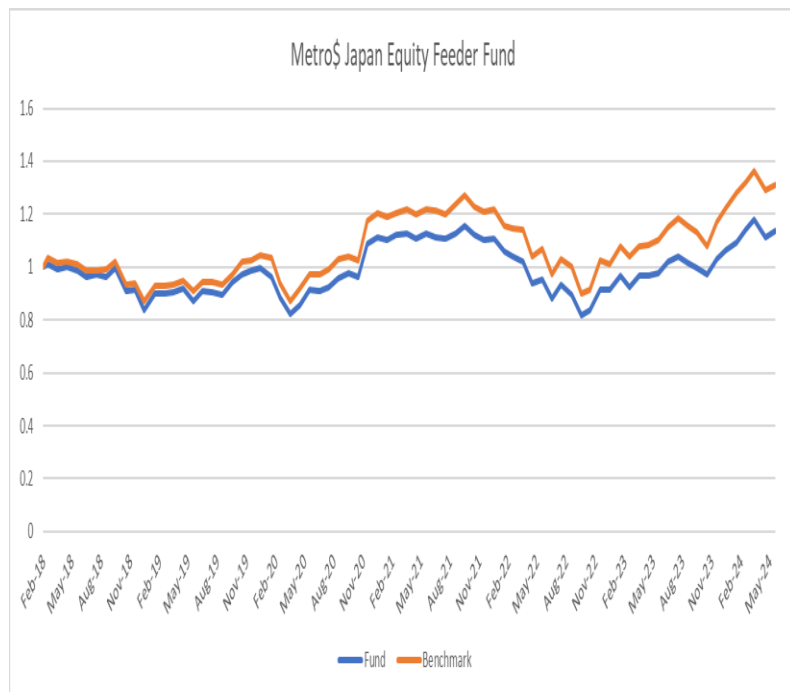

³ Sharpe Ratio is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better.

⁴ Information Ratio measures reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk.

⁵ Tracking Error measures the deviation between the Fund's return and benchmark return since the Fund's inception. The lower the number, the more aligned the Fund's return is with the benchmark. (Starting September 2021 report the basis for the Tracking Error computation is since the Fund's inception.)

INVESTMENT POLICY

A. The Fund may be invested and reinvested in the following instruments:

- USD-denominated units/shares in collective investment schemes subject to the conditions under BSP Circular 767
- USD-denominated deposits
- Other traded money market instruments
- Other USD-denominated Investments allowed under BSP regulations

B. The Investor Fund may invest a minimum of 90% of its fund in the Target Fund and a maximum of 10% in cash, deposits and other money market instruments. The investment of the Investor Fund in any Target Fund shall not exceed 10% of the Total Net Asset Value of the Target Fund.

OUTLOOK AND STRATEGY

The fund increased by 2.30% for the month of May. Despite efforts from Japanese authorities, household spending and confidence continue to remain muted. The continued decline of the Yen to 157.73 versus the US dollar contributed to limited upside.

The BOJ left rates unchanged at accommodative levels of 0.1% in May. Despite the support from the Japanese government, growth and consumption has yet to improve for the country. The slide of the Yen from 151.39 to 157.73 against the dollar has become a growing concern for investors.

In May, CPI YoY continued to decline to 2.5% from 2.7%. Retail sales MoM declined 1.2% from a positive reading of 1.5% the month prior, as consumer confidence decline from 38.3 to 36.2. Household spending remained muted, declining 1.2% despite a slowdown of inflation pressures. Joblessness remained unchanged at 2.6%. Japan's PMI data for manufacturing and services increased to 49.6 and 54.3; respectively. While it seems, Japan has exited the long era of deflation, stagflationary risk may emerge as overall consumption remains muted.

The de-escalation of tension in the Middle East aided the recovery of Japanese markets in May. While Japanese market remain in a strong uptrend, weak sentiment, consumption may play a role in the sustainability of the uptrend as the BOJ looks to increase policy rates further in the 2nd half of 2024.

In the short to medium term, the evolving soft-landing narrative raises concerns about stagflation, given fiscal spending ahead of the 2024 U.S. Presidential elections, while suppression of consumption emerges from the high interest rate environment.

The fund is capitalizing on favorable dollar time deposit rates, offering a 90-day yield of 5.30%.
