INVESTMENT OBJECTIVE AND STRATEGY

The Investor Fund is a USD-denominated equity Unit Investment Trust Fund structured as a feeder fund and aims to provide market returns from a representative portfolio of stocks that comprise the China Equity Market by investing at least 90% of its assets in the iShares MSCI China A UCITS ETF USD.

The Fund's benchmark is the MSCI China A Inclusion Net Return USD Index.

CLIENT SUITABILITY

A client profiling process is performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are encouraged to update the resulting profile every three (3) years or if there's any change in his/her personal/financial circumstances. Before deciding to invest, clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, or seek an independent/professional opinion when necessary.

The METRO\$ CHINA EQUITY FEEDER FUND is suitable only for investors who:

- Have an Aggressive profile.
- Want capital appreciation over the long-term by primarily investing in iShares MSCI China A UCITS ETF USD.
- Recommended investment horizon is at least five (5) years
- Participation in the Investor Fund shall be open to Filipino individuals, resident and non-resident aliens, and corporate accounts. However, persons from USA, and Canada are not allowed to open an account.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Market/Price Risk:	The possibility for an investor to experience losses due to changes in the market prices of stocks/equities. It refers to the portfolio's exposure to marked-to-market valuation due to market price fluctuations of the stocks/equities.
Liquidity Risk:	The possibility for an investor to experience losses due to the inability to sell or convert assets into cash immediately or in instances where conversion to cash is possible but at a price that could result in a loss. 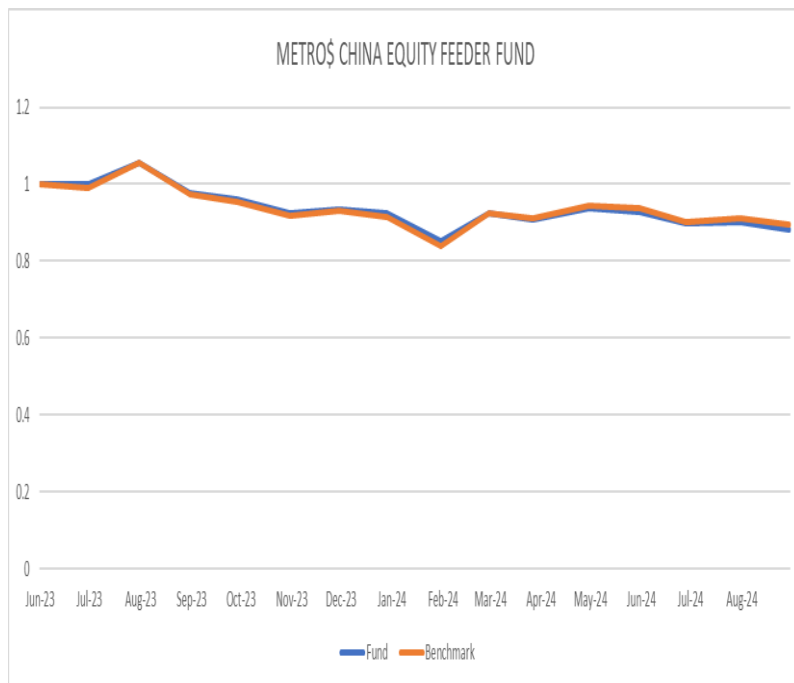

⁴ Information Ratio measures reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk.

⁵ Tracking Error measures the deviation between the Fund's return and benchmark return since the Fund's inception. The lower the number, the more aligned the Fund's return is with the benchmark. (Starting September 2021 report the basis for the Tracking Error computation is since the Fund's inception.)

INVESTMENT POLICY

A. The Investor Fund may be invested and reinvested in the following instruments:

- USD-denominated units/shares in more than one collective investment schemes subject to the conditions under BSP Circular 767
- USD-denominated money market instruments
- USD-denominated deposits
- Other USD-denominated Investments allowed under BSP regulations

B. The Target Fund may be invested and reinvested in the following instruments:

- Global-denominated Investments allowed under regulations issued by the Bangko Sentral Ng Pilipinas;
- Global-denominated Exchange-listed securities;
- Global-denominated deposits with local banks/foreign banks
- Financial derivative instruments for hedging purposes and efficient portfolio management.

C. The Investor Fund may invest a minimum of 90% of its net asset value in more than one (1) Target Fund and a maximum of 10% in cash, deposits and other money market instruments

OUTLOOK AND STRATEGY

The fund decreased by 2.23% in August. Unresolved concerns stemming from the property sector continue to be a long-term weak point for China. The rally stalled as the stimulus effect ran dry.

The People's Bank of China (PBOC) kept its 5-year loan rate at 3.85% and its 1-year loan rate at 3.35%, following the unexpected reduction by the government to combat deflationary pressures in the country. The second rate cut by the PBOC in 2024 was aimed at supporting demand in the ailing property sector. GDP for Q2 2024 was 4.7% YoY, down from 5.3% in the first quarter. Manufacturing PMI declined to 49.1, while services PMI inched higher to 50.3. The jobless rate remained steady at 5.0%, but undisclosed youth unemployment may become a structural problem if left unresolved.

Retail sales improved to 2.7% from 2.0% YoY, following a sharp decline from 3.7% last month. Despite government efforts to stimulate the economy, the tangible impact has been temporary. Overall, China's property market remains a clear drag, with new home prices continuing to decline by 0.65% in August.

The stimulus provided by the government halted the investor exodus in Q1 2024. However, the sustainability of economic recovery in the challenged property sector has faltered, pushing the initial up-move to break down once more. The inverse head-and-shoulders pattern, a potential bottoming signal, has failed, prompting prices to re-enter the long downtrend. Since then, prices have moved sideways with a downward bias. Tactical mean-reverting strategies—buying low and selling high in short price ranges—are recommended for now.

The last 60 days heading into the 2024 U.S. Presidential elections will add noise to an already volatile macroeconomic environment. The world watches as the U.S. prepares to ease rates for the first time since the pandemic lockdowns. A transition into a risk-off scenario can be expected in the coming quarters, with the current bias toward deflation.
